It is informed to all concerned that on the request of the students, the Vice-Chancellor has allowed to grant **Special Mercy Chance on the 575<sup>th</sup> birthday celebration of Guru Jambheshwar ji Maharaj** for the students of all UG/PG courses who couldn't pass their course within the admissible chances/maximum duration of the course as provided in the scheme of exam till the last exam for May/June/July/August/September 2025, subject to fulfilment of following criteria/conditions: -

1. That student who enrolled himself/herself for their particular course from 2011 onwards and availed all his/her admissible chances as provided in the Scheme of Exam, stands availed/exhausted till the last exam for May/June/July/August/September-2025, shall only be eligible for this special mercy chance. If anyone who has any admissible chance to pass the degree at his/her credit, as of now, shall not be eligible for this special Mercy chance. **However, it is clarified that the students of following courses during the duration as indicated against each may apply for this Special Mercy Chance: -**

- **For the courses of University Teaching Departments (UTD)/Affiliated Degree Colleges/LAW College/Distance Education (CDOE)/old Affiliated Engg. & Management Colleges as under: -**

2. That the examinations (Theory/Practical/Viva-Voce/Comprehensive Viva-Voce) of the papers of odd semesters as well as even semesters will be conducted separately as per convenience of the University. For this Special Mercy Chance, the portal on the University Website for filling examination forms for UTD/Affiliated Degree Colleges/LAW College/old Affiliated Engg. & Management Colleges (**Except Education & Distance Education**) for odd semesters only shall be live from 01.09.2025.

Further, Schedule of Education and Distance Education Courses for odd & even semesters/yearly courses and for UTD/Affiliated Degree Colleges/LAW College/old Affiliated Engg. & Management Colleges for even semesters courses schedule will be declared later on. **Students are advised to remain in touch with University website [www.gjust.ac.in](http://www.gjust.ac.in) for updates (if any).**

3. That examination for special chance shall be held in **offline mode only** and at the premises of University Campus/affiliated college(s) to be decided according to the strength of students going to appear in the exam. No online examinations (Theory/Practical/Viva-voce/comprehensive Viva-voce) will be held under any circumstances for this special mercy chance.
4. That for this special mercy chance, Fee will be charged from the students of all courses run in the University Teaching Departments as well as in Affiliated Degree/Law/Engineering/Education/Management Colleges and under Directorate of Distance Education as per details mentioned below: -

1. **For the courses of UG/PG/PG Diploma's from batch 2011 onwards will be charged Rs. 16000/- per Semester/Annum alongwith normal fee and late fee (if any).**

**Note: - Fee once paid shall not be refunded/adjusted under any circumstances.**

5. Students are also advised that before submission of online examinations form and fee, they must check/ensure their eligibility, and in case of any doubt, they must confirm it from the Result Branch concerned. If any "INELIGIBLE STUDENT/CANDIDATE" submits his/her examination form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case. All the students desirous of availing this chance are advised to read the following conditions/instructions carefully: -

- i) The examination for the special mercy chance shall be conducted as per the scheme/syllabi, as applicable for each course. In case of old students, where syllabus is not available in the concerned branch, such candidates are not permitted to avail special mercy chance and fee of these students will be refunded.
- ii) The examination forms and fee shall be filled up through online mode to be notified by the University.
- iii) The schedule of examination/declaration of result will be notified depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of their respective results.
- iv) This special mercy chance is admissible to complete the Degree (course) for such students who have re-appear in one or more papers (subjects) and also for improvement of division, who could not improve division within their admissible chances. **However, Improvement is not permissible for Education courses (B.Ed/B.A. B.Ed/M.Ed/B.Ed (Shiksha Shastri), B.Ed-M.Ed(Integrated)/ Bachelor of Ele. Edu./B.Ed. (Part Time).**

**Note: - The student who was not attended the classes regularly and left the course/whose name was struck off is not eligible for this special mercy chance.**


- v) The students desirous of appearing in the above special mercy chance

examinations shall apply through the online mode with the prescribed fee mentioned in the examination schedule issued separately by the university.
