Declaration Certificate

1. The university shall scrupulously abide by the following terms and conditions, while offering the programmes through distance learning mode during the session 2016-17 in accordance with the terms and conditions mentioned below.

- i) The University shall offer only those programmes through Open and Distance Learning (ODL) mode, which are approved by the statutory bodies of the University as per norms and also by UGC and wherever necessary by the apex regulatory bodies in the country.
- ii) It is the responsibility of the University to follow the norms prescribed by the concerned regulatory body/ies such as UGC, AICTE, NCTE/any other and also seek its/their prior approval, wherever required.
- The University shall not start any new programme without prior approval of UGC and other concerned regulatory authorities in anticipation of recognition.
- iv) The nomenclature of all the programmes to be offered under distance mode shall be strictly as per UGC/AICTE Regulations.
- v) No teacher education programme shall be offered without prior approval of the NCTE.
- vi) The Ministry of HRD's directions prohibiting B.E/B.Tech through distance mode vide it's letter dated 29.07.2009 shall be adhered to strictly.
- vii) The programmes in Engineering and Technology e.g. B.E/ B.Tech/ Diploma and courses in Medicines/ Nursing/ Physiotherapy etc. are not allowed and the University will not be offering the same.
- viii) The university shall refrain from offering such programmes that are not allowed to be offered, through distance mode by the respective apex body/ies.
- ix) No online programme leading to award of Degree/ Certification shall be offered by the University, until a policy is framed and approved by UGC in this regard.
- x) The minimum duration of a programme offered in ODL mode shall not be less than the minimum duration of similar programme offered through the regular mode.
- xi) The University shall run its ODL programmes only in those subjects/ fields which are offered by it through regular mode.
- xii) The university shall have at least one full time faculty member exclusively for coordinating each programme at the headquarters
- xiii) The eligibility conditions for admissions to each course to be offered through distance learning mode shall be as per norms of UGC/AICTE and other regulatory bodies.
- xiv) The territorial jurisdiction in respect of University for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of

off campuses/centres/study centres as mentioned in the UGC notification No.F.27-1/2012(CPP-II), dated 27th June 2013, a copy of which is also posted on the UGC website www.ugc.ac.in/deb.

- XV) The programmes in distance mode will not be offered through franchising arrangement and /or through any private institution /college
- xvi) The Institute shall not offer any M.Phil/Ph.D Programme through distance learning mode in compliance to clause 5 of the UGC (Minimum Standard and Procedure for awards of M.Phil/Ph.D Degree), Regulation 2009.
- xvii) The Institution's management of the distance education programmes will be open for review and inspection by the UGC. The academic norms of the programmes shall be under monitoring by the concerned regulatory authorities.
- xviii) The institution has furnished complete information regarding ODL programmes on its website as per UGC instruction.
- xix) (i) If the institution fails to comply with the conditions of recognition for which the affidavit, as mentioned above has been submitted or if it is found conducting affairs in a manner that leads to deterioration of academic standards, the UGC may withdraw its recognition.
 - (ii) In case any information, documentary evidence submitted/produced by the University/institution is found to be false or fake at a later stage, the recognition of University/Institution shall be withdrawn and the University/Institution concerned shall be solely responsible for the career consequences, if any arising out of the same.
- **4.** The information provided is only for the purpose of Recognition process, which will be considered by UGC. The institution shall not consider that submission of these documents ensures recognition for offering ODL programmes

The Directorate of Distance Education was started w.e.f. the session 1997. To begin with MMC, BMC and BBA courses were launched from the session 1998-99. The actual income of the Directorate during this year was Rs.38,80,681/-. The estimated receipts for the year 1999-2000 were Rs.54,98,000/- and it was Rs.80,00,000/- lacs for the year 2000-2001. The above estimates were placed before the Finance Committee in its meeting held on 23.3.2000 which made the following recommendations vide resolution No.3(iii):-

"The University has shown mobilisation of internal income through imparting of distance education. University may launch other courses which shall bring in more revenue to University. For strengthening Directorate of Distance Education complete scheme prepared may bе generated and indicating revenue to be minimum requirement of manpower submit the same to the Govt. through appropriate channel."

The above recommendations of the Finance Committee were approved by the Executive Council vide Resolution No.19 of its meeting held on 27.3.2000. In view of the above decision of the Executive Council the Directorate started two new courses namely P.G.D.C.A. and M.Sc. (Computer Science) w.e.f. the session 2000-2001. As a result of introduction of these courses the total income/receipt during the year 2000-2001 has reached Rs.2,17,54,235/- (audited).

There is no sanctioned post for the Directorate of Distance Education. Therefore, skeleton staff from other branches has been posted in the Directorate of Distance Education to carry out the work of these courses. Besides, four superannuated personnels have been engaged on contractual basis @ Rs.5000/- per month in order to meet the increased workload.

From the session 2001-2002, three new courses namely; Master in Insurance Business (MIB), Post Graduate Diploma in Taxation (PGDT) and Post Graduate Diploma Environmental Management (PGDEM) introduced. In addition, four new courses viz. Bachelor of Computer Applications (BCA), Post-Graduate Diploma in e-Commerce Technology (PGD-e-Com), Advanced Diploma in Web Programming (ADWP) and Diploma in Computing (DIC) have been launched in collaboration with Aptech Limited, Mumbai. the workload has increased Consequently, been manyfold. Also the Directorate proposes to start three new course i.e. MBA, MCA and P.G.Diploma in Web Content Development and Cyber Journalism from the next session i.e. 2002-2003 which will further add the workload. In view of this, the posts referred to above are required to be created to carry on the work total effectively and smoothly. \mathbf{The} approximate liabilities on account of creation of the aforesaid posts will be to the tune of Rs. 27, 27, 200/-. A note containing the justification for creation of the aforesaid posts and showing the actual receipts the Directorate for the year 2000-2001 is at Annexure-XXVIII Pages 48-52.

The matter was placed before the Vice-Chancellor who has desired that the same may be placed before the Executive Council in its ensuing meeting for consideration and approval. After approval of the Executive Council, the matter will be placed before the Finance Committee and thereafter it will be referred to the State Govt. for favour of approval.

1. The Institution will offer only such programmes through distance mode which are offered by the Institution through regular face-to-face mode and approved by the Joint Committee of UGC AICTE-DEC as mentioned in this letter. The Institution will not offer any other programme though distance mode other than those approved by the Joint Committee of UGC-AICTE-DEC.

The nomenclature of the programmes should be strictly as prescribed by the UGC/AICTE and approved by the Joint Committee of UGC-AICTE-DEC.

The eligibility conditions and duration of programmes will be as per the DEC norms and for professional and technical programmes as per the norms laid down by the AICTE. No admission to MBA, PGDBM and MCA programmes can be done without ensuring that that the student has secured a valid score in the entrance test examination for this purpose.

The Institution shall limit admission to maximum 60 seats per programme per Study Centre for Management, Computer & IT, and Allied Health Sciences programmes. For laboratory/Practica work, the institution can have a maximum of 30 students in a batch subject to maximum 60 students per Study Centre. The Study Centre be owned by the University and should be opened with the approval of EC/BOM of the University concerned.

The Institution should have at least one full time faculty member exclusively for coordinating each programme.

Regarding territorial jurisdiction for offering programmes through distance mode the latest UGC notifications will prevail over all previous notifications and circulars. As per the UGC notification State Universities (both private as well as Govt funded) can offer programmes only within the State and Deemed Universities from the Headquarters and in no case outside the state However, Deemed Universities may seek the permission to open off campus centers in othe states and offer distance education programmes through the approved off campuses only afte approval of UGC and DEC. Central Universities will also adhere to the UGC norms. The territoria jurisdiction for the institutions (both private as well as Govt funded) shall be the Headquarters and in no case outside the State. Thus, the territorial jurisdiction of your Institution shall be Harvana State.

The Distance+ Education Council prohibits franchising of Study Centres. Thus, your Institution will not franchise any Study Centre.

The Institution's management of the distance education programmes will be open for review and inspection from time to time by DEC to provide inputs for further improvement or as deemed necessary. The academic norms of the programmes shall be under monitoring and regulation by the concerned regulatory authorities.

For management and Computer Science programmes, the Institution should also note that

· The programme should have a mandatory internship of six months;

 Institute/University concerned should seek accreditation from National Board of Accreditation as per prevailing rules;

Institute/University concerned should have concerned Department and the conventions
universities should have on campus programme on offer;

Institute/University concerned should not have advertised for the programmes before receiving the approval letter;

Institute/University concerned should disclose, on line, in public domain the details of the student admitted, centre-wise, as per the format to be prescribed by AICTE;

 Institute/University concerned should ensure delivery of the course material on-line with in one year of the date of approval;

It may be noted that before launching the programme the institution should submit an affidavit within 30 days from date of Issue of this letter that it agrees to and will abide by all terms and condition contained in this letter in case, the DEC does not receive the affidavit within 30 days from date c issue of this letter, the approval accorded to your Institution will be considered as withdrawn. Further if it is found that the Institution is flouting any norms, then the recognition accorded to your Institution will be withdrawn without any notice.


